In-kennel training: \$512.5 per week; one-week non-refundable down-payment is required to save the spot.

- RR Professional Dog Training (“RR”) cannot make any guarantee regarding the outcome of any training program. The Owner assumes full responsibility for the dog’s behavior during and after the training/counseling program.
- The Owner understands and agrees that the success of any training program is contingent upon the willingness of the Owner to handle and/or work with their dogs as suggested by their trainer.
- **LIABILITY:** The Owner waives RR from any and all liability of any nature. This includes any injury, death, sickness or damage their dog(s) may suffer during or after any training program. The Owner also agrees to indemnify and hold harmless RR from any and all claims due to damage the dog(s) may cause to any employee, property or third-party persons during or after training. The Owner specifically acknowledges that they recognize the risk of taking a group class with other people and their dog(s). This risk is entered into with the Owner 100% responsible for their dog’s behavior at all times in the class environment.
- The Owner/agent will be responsible for purchasing all necessary equipment that the trainer recommends for training the dog(s).
- **TERMINATION OF TRAINING:** The Owner of the dog(s) may have the animal withdrawn from training at any time. However, once training has begun, all fees are non-refundable.
- In the event that training or training charges are not paid, Owner shall be responsible for all collection costs including attorney’s fees.

FOR IN-KENNEL TRAINING DOGS ONLY

- RR Professional Dog Training (“RR”) reserves the right to immediately change your dog(s) type of boarding if we believe it is necessary to protect the health and well-being of your dog(s), other dog(s), or our staff, and Owner agrees to pay any additional costs associated with the change.
- Owner agrees to pay all costs and charges for special services requested, and provide updated vaccination records from your vet before starting training or boarding.
- Owner agrees to be solely responsible for any and all acts or behavior of Owner’s dog(s) while the dog(s) are in the care of RR.
- In the event charges are not paid when due in accordance with this agreement, Owner shall be responsible for all collection costs including attorney’s fees.
- If the pet becomes ill or if the state of the animal’s health otherwise requires attention, RR, at its sole discretion, is authorized to engage any local vet up to \$300. If a veterinarian determines that emergency treatment, which exceeds the authorized amount, is needed to save the animal’s life or quality of life, and we cannot reach you or the Emergency Contact, we may authorize the veterinarian to perform the emergency treatment.
- Owner agrees to be responsible for all veterinary costs provided to your animal.
- Owner agrees to release, indemnify, and hold harmless RR Professional Dog Training from any and all manner of damages, claims, loss, liabilities, costs or expenses, including reasonable attorney’s fees and related costs, arising out of or related to RR services, except which may arise from the gross negligence or intentional and willful misconduct of RR.
