\_\_\_\_\_ RR Professional Dog Training (“RR”) reserves the right to immediately change your dog(s) type of boarding if we believe it is necessary to protect the health and well-being of your dog(s), other dog(s), or our staff, and owner agrees to pay any additional costs associated with the change.

\_\_\_\_\_ Owner agrees to pay all costs and charges for special services requested, and provide updated vaccination records from your vet before starting training or boarding.

\_\_\_\_\_ Owner agrees to be solely responsible for any and all acts or behavior of Owner’s dog(s) while the dog(s) are in the care of RR Professional Dog Training.

\_\_\_\_\_ Owner agrees that in the event the boarding charges are not paid when due in accordance with this agreement, that RR Professional Dog Training may commence collection proceedings including, but not limited to, small claims action in court.

\_\_\_\_\_ If the pet becomes ill or if the state of the animal’s health otherwise requires attention, RR, at its sole discretion, is authorized to engage any local vet up to \$300. If a veterinarian determines that emergency treatment, which exceeds the authorized amount, is needed to save the animal’s life or quality of life, and we cannot reach you or the Emergency Contact, we may authorize the veterinarian to perform the emergency treatment.

\_\_\_\_\_ Owner agrees to be responsible for all veterinary costs provided to your animal.

\_\_\_\_\_ Owner agrees to release, indemnify, and hold harmless RR Professional Dog Training from any and all manner of damages, claims, loss, liabilities, costs or expenses, including reasonable attorney’s fees and related costs, arising out of or related to RR services, except which may arise from the gross negligence or intentional and willful misconduct of RR.
